

## REGULATIONS

### Art 1

DG Consultants, 5/7 rue de l'Amiral Courbet, 94160 Saint Mandé, organises the Innovation Prize as part of the 14<sup>th</sup> edition of Les Assises de la Sécurité et des Systèmes d'Information, which will be held in Monaco from Wednesday 9 October to Saturday 12 October 2019, a free contest with no purchase necessary.

### Art 2

Participation is open to any company created in **2016, 2017, 2018 or 2019** in a member State of the European Union, Switzerland or Norway and UK. The company must present an innovative solution in information system security and have received European Union funding.

Companies having participated in a previous edition of Les Assises or Ready for IT events on their own behalf are ineligible.

Companies entering the Innovation Prize may not be Partners of Les Assises 2019.

Only the company's initial creation date will be taken into consideration.

The jury reserves the right to refuse entry if the company has been recreated, acquired, changed status, or if any other event changes its creation date.

### Art 3

Applications must be completed on line at: <https://www.lesassisesdelasecurite.com>, Innovation Prize, from **11 February to 1 May 2019 at midnight**.

### Art 4

**Participants must complete their entry on line in electronic format.**

- The information contained in the entry will be disclosed only to jury members for evaluation purposes. Information disclosed to the jury will remain confidential, except for the company presentation/project purpose which will be published on the website and in the press.
- Participants may include a more complete presentation of their project as well as any documents that would assist the jury in its selection process, preferably in electronic format (one or two attachments in pdf format, maximum 5MB, to be uploaded to the website).
- In order to demonstrate the viability/performance/sustainability of their solution, participants must include a demo video posted on a YouTube channel (with private access).or test platform
- The list of candidates chosen for the elevator pitch will be published on the Les Assises website (logo, company presentation and website link).

Candidates selected for the elevator pitch may be contacted by one of the members of the jury prior to the elevator pitch. This meeting will permit jury members to obtain details of the project for the final vote.

#### Art 6

**Jury members may not enter the Innovation Prize on their own behalf or on behalf of the organisation to which they belong, or be a stakeholder in any of the projects.**

#### Art 7

**Entries will be evaluated by the jury on the basis of a number of criteria, including:**

- The innovative and novel nature of the solution
- The solution's technological innovations
- Its interest for CISO/IS managers
- The project's state of advancement

Jury members have all powers to appreciate the quality of the projects presented by candidates. Projects may be of any nature: products, services or a combination thereof. Jury members examine entries in written form although they may request to view the proposed innovation if necessary.

#### Art 8

Top entries chosen by the jury will be invited to present their application in an elevator pitch at the **Le Cercle meeting on 27 June 2019** (Pavillon Cambon-Capucines-Paris). Meeting attendees will vote for a special People's Choice award. The jury may consider this choice in its final selection of the Innovation Prize winner on 1st July 2018.

#### Art 9

**The jury will announce the Innovation Prize winner on 1st July 2019.**

#### Art 10

The Innovation Prize will be presented officially to the winner at the plenary conference of **Les Assises de la Sécurité et des Systèmes d'Information on Thursday 10 October 2019**.

The Innovation Prize winner will receive admission to Les Assises plus a "module", a fully furnished 9 m<sup>2</sup> stand, valued at €36.750 plus VAT, as well as a workshop at which it will present its offer.
